This planning process includes ALL Bear Lake users and will be used to coordinate and develop management practices of the beaches on the Idaho side. So read up and send your comments.

Hi Bearlakers,

The Public Draft of the Management Plan for Utah Sovereign Lands at Bear Lake is now out for public review and comment. The agency, contractor and working group have worked on this for months. Now it is your turn. There will be two public meetings (see side panel for details >>) and comments will be accepted until mid March. This is your last opportunity to comment before the plan becomes final!

Important!

- This plan is the "framework" for decision making on the lake .
 - Commercial /Industrial Leases
 - Rules for public use
 - Weed &Pest Management
 - Agency Management Practices
 - and more
- When this plan is officially on the books, it will be the basis of what type of leases will be considered.
- FFSL is not proposing any specific uses, but will again be accepting applications for leases on the sovereign land.

1. Anticipate some scenarios or proposals that might occur
2. Evaluate what the guidance of the plan provide
3. Determine whether or not the outcome would be good for Bear Lake in general and for the areas of the beach you use.
